## Minutes of the Liquor Control Commission

The Liquor Control Commission of the McLean County Board met on Tuesday, April 15, 2014 at 10:55 a.m. in Room 404, Government Center, 115 E. Washington Street, Bloomington, Illinois.

Chairman Sorensen called the meeting to order at 10:55 a.m. He noted that the first item for action is approval of the minutes from the June 18, 2013 Liquor Control Commission Meeting. Chairman Sorensen presented the Minutes to the Committee for approval.

Chairman Sorensen continued with the Request for Approval of the Annual Liquor License for 2013-2014 for Suketu Trivedi Inc. dba Bloomington Fast Stop.

Mr. Mark Messman, Assistant State's Attorney advised that he has reviewed the application that was filed with the McLean County Clerk. He noted that this is simply the sale of business from a pre-existing licensee to the new applicant. The License will be valid for two months. The applicant will then file for annual renewal in June, 2014.

Mr. Wendt asked for the location of the business. Mr. Messman responded the business is located on south US 51.

Chairman Sorensen reiterated that this is a two months license for the new operator at the same location.
