Minutes of the Liquor Control Commission

The Liquor Control Commission of the McLean County Board met on Friday, June 19, 2015 at 11:00 a.m. in Room 404, Government Center, 115 E. Washington Street, Bloomington, Illinois.

Chairman Sorensen called the meeting to order at 11:05 a.m. He declared a quorum present and noted there was one item on the agenda for approval; the application for 2015-2016 Liquor License of Graybill Limited dba Lake Road Inn – Craig Hanson.

Chairman Sorensen asked if any changes had been made from the previous owner of the Lake Road Inn.

Mr. Hanson stated that many improvements had been made including the parking lot, internal decor and kitchen improvements. Mr. Hanson discussed the updated cuisine and beverage choices now available at the establishment. He stated only 50% the staff had been retained and that employee training and new staff rules had been implemented. Mr. Hanson stated that he wants the Lake Road Inn to be family oriented.

Ms. Schaffer asked about the Graybill Limited name on the application.

Mr. Hanson responded that it was a full stock purchase.

Chairman Sorensen indicated that Mr. Hanson was in the process of providing documentation to the Health Department so he could also seek a Class G license. Mr. Sorensen asked the Commission to consider approving a Class G license contingent on approval by the Health Department.

Motion by Cavallini/Schafer to approve the application for 2015-2016 Liquor License Class A and Class G License contingent on receiving documentation from the Health Department that proper criteria have been met.
Motion carried (Chairman Matt Sorensen voted).

Chairman Sorensen instructed the State's Attorney to make sure that proper documentation was acquired before processing the Class G license.

Chairman Sorensen asked if there were any other questions or comments regarding the application or if there was any other business for the committee. Hearing none, he adjourned the meeting at 11:17 a.m.
