Those persons wishing to provide public comment (by phone or in person) must register [https://mcleanil.seamlessdocs.com/f/public\\_comment](https://mcleanil.seamlessdocs.com/f/public_comment) 24 hours in advance of the meeting (for comments relating to an item on the agenda) and 48 hours in advance (for comments not related to an item on the agenda).\*

When you register, you will receive an email confirmation of your request. You will then be contacted by a member of the Administrative staff to discuss your options for public speaking (in person or via phone).

In addition, and as per County Board Rules, §20-15 (I), appearances by non-members shall be five minutes for each individual or representative spokesperson of a group. Due to the nature of the meeting, the rule's limitations on total number of minutes for all public speakers will be adjusted, beyond the requisite 30 minutes in total, should the number of public registered to speak require extension of the 30 minutes in total portion of the rule.
