Registration: This is an automated tax sale. Our contractor for the automated sale is RAMS. Participants will use a computer terminal that is provided during the day of the tax sale. The statutory registration fee of \$250.00 is required along with registration forms. Attendance at the sale is mandatory. The registration fee will be applied towards any purchases or returned if no purchase occurs. The fee will be forfeited for non-attendance. The tax sale results will be communicated by email and loaded to our website. IRS Form W9 must be submitted with a new buyer registration.

Completed registration forms must be **received** by **October 18, 2018** which is 10 business days prior to tax sale. Forms may be submitted by mail, emailed to [treasurer@mcleancountyil.gov](mailto:treasurer@mcleancountyil.gov) or faxed to 309-888-5176. Registration fees are to be mailed the same day as emailed or faxed registrations. Retain the fax or email record for verification of electronic submission of tax sale registration packet.

Parcel List: Parcel list will be available October 22, 2018 at a cost of \$50.00 payable in advance with the tax sale registration. The list will be emailed by RAMS and updated lists will follow at no additional charge.

Printed lists are available through our office. The cost is \$50.00 payable in advance with the registration. If mailing is required, include an additional \$5.00 for postage. Updated printouts will be available upon request for an additional cost of \$15.00. If mailing is required, include an additional \$5.00 for postage. Please contact the office at 309-888-5180 or email [treasurer@mcleancountyil.gov](mailto:treasurer@mcleancountyil.gov) to order the printed list prior to arriving.

Terms of Sale: Tax Sale Purchaser will be required to sign an agreement stating

- you will be buying taxes
- you will follow the sale procedures as required by law
- you will not buy any taxes for property in which you have an interest
- you will pay immediately in the form of cash, money order, or check
- only 1 buyer per company is allowed to bid at the tax sale

If you do not comply with the terms of the agreement, the tax sale may be voided and the parcel(s) will again be offered for sale.

Subsequent Taxes: Subsequent tax payments will be accepted September 24 (tentatively) thru October 31, 2018. Notify us a day in advance so we can have the bills ready. **Tax buyer must visit the County Clerk's office to obtain verification that redemption has not occurred immediately before coming to the Treasurer's office.**
