Thank you for your continued interest in serving as a McLean County Election Judge.

All new and veteran judges are required by state statute to complete our training course. The 2022 elections are the Primary Election on Tuesday, June 28 and the General Election on Tuesday, November 8. We look forward to introducing you to our new election equipment which will continue to provide for the safety, security, and ease of use for our election process.

Let's get you scheduled for training!

As an Election Judge you play an important role in maintaining the integrity of the election process. Placement will depend upon your successful completion of training along with the availability of polling places. If you have a location preference, please indicate that on the sign-up form included in this mailing. If you are willing to work at any polling place in rural McLean County, or prefer a location in Normal only, please so indicate. Remember, we have two Election Authorities. Our office serves all McLean County except City of Bloomington. However, all residents of McLean County, including City of Bloomington residents, can work for our jurisdiction. You can find all our polling place locations by going to our website and clicking on the "Elections" link.

If you complete training and are confirmed to work Election Day; you will again earn \$200.00 for your long day which begins at 5:00 am. Polls open promptly at 6:00 am and close at 7:00 pm. Depending upon voter turnout, you can expect to head for home around 8:00 pm. If you work outside your home polling place, you will also be paid mileage. We have included a sign-up form with the available training dates and times. Because we have limited room at each session, **please respond as soon as possible**. Indicate with a "1" by your first choice, a "2" by your second choice, and a "3" by your third choice.

Training will be held at the Government Center, 115 E. Washington St. in downtown Bloomington. We will have signs posted directing you to the classroom which is in the basement area. Training sessions last 3 to 4 hours. **We suggest you park in the parking garage on Front Street. Please bring your parking ticket in with you and we will validate it so you won't have to pay for parking.** Refreshments will be provided.
